- 2.5 "Board" means the Board of directors of the Company.
- 2.6 "Company" means Blue Chip Tex Industries Limited.
- 2.7 "Events or Information" refers to the information/ events that are required to be disclosed on the website of the Company in terms of Regulation 30(8) of the Regulations and other Applicable Law.

2.8 "Regulations" means the Securities and Exchange Board of India (Listing Obligation and Disclosure Requirements) Regulations, 2015

3. Coverage

The archived documents will be available in the archived folder for a period of one year. After the expiry of one year, the archived disclosures/ announcements shall be removed from the website of the Company.

8. Interpretation

Notwithstanding anything contained in this Policy, the Company shall ensure compliance with any additional requirements as may be prescribed under any laws/regulations either existing or arising out of any amendment to such laws/regulations or otherwise and applicable to the Company, from time to time.
